New trademark rules came into force in India in March 2017, which ushered in several notable changes: they allow for the registration of sound marks; enable expedited prosecution; and provide for the electronic service of documents. The applicant classification system was also changed, with a distinction being drawn between start-ups and small enterprises on the one hand and larger companies on the other; while official fee increases are limited for those in the former group, they are much greater for the latter. These developments indicate that the government is paying greater attention to IP issues. Notwithstanding complaints surrounding attempts to tackle the backlog of cases at the Indian trademark office, this has been welcomed as a positive step by the country's IP community.
